Initially, by the effect of the orders of the Hon'ble High Court of A.P dt.18-10-2011 in W.P No.29418/2010 and batch, the seniority of AEs/Elecl appointed on contract basis during 2005 duly taking their service on contract in accordance with T.O.O (Addl.Secy.-Per) Ms.No.231,dt.23-12-2008 and clarification Memo dt.23-9-2009 was fixed and communicated in the memo 12th cited.

2. Subsequently, the Division Bench of Hon'ble High Court vide Judgment dt:17.09.2013 held that, "the view taken in the impugned common order is liable to be set aside. Accordingly we hereby set aside the common order. Consequently T.O.O.Ms. No.231. dt:23.12.2008 is also hereby quashed. We therefore hold that the AEs appointed on contract basis are not entitled to reckon their services as such, for the purpose of seniority and that they are entitled to compute their service for the purpose of seniority only from the date of their regularization in that post, but not otherwise".

3. As per the orders of Division Bench of the Hon'ble High Court the APTRANSCO vide T.O.O Ms.No.19, dt:26.11.2013 has cancelled the orders issued vide T.O.O Ms.No.231, dt:23.12.2008.

4. During further course of time the AEs recruited on contract basis filed review petition which came to be dismissed. Again SLP was filed by AE's appointed on contract basis. Later Hon'ble Supreme Court passed Final Orders Dt.23.01.2017 in SLPNos.13858-13859/2015, 15389-15390 of 2015 and batch cases stating that, "we do not see any ground to interfere with the impugned order (s). The special leave petitions are accordingly dismissed. Pending applications, if any, shall also stand disposed of". The said orders dt:23.01.2017 requires restoration of seniority of AEs appointed by transfer.
