**O R D E R :**

Under Regulation 14(a)(1) of A.P.S.E. Board S.Rs – Part-II as adopted by A.P Transco, **THREE** Asst. Accounts Officers mentioned in the Annexure appended to this order, are promoted temporarily to act as Accounts Officers with effect from the date of assumption of charge.

2. The promotions ordered in para-1 above are purely temporary for administrative convenience and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotions ordered in para-1 above are subject to result of appeals filed by the Retired Officers of the erstwhile Board against the judgment in WP.Nos .2360-91/83 and pending in the Hon'ble Supreme Court of India.

4. The promotions ordered in para-1 above are also as per Rule of reservation in promotion in favour of S.Cs and S.Ts as adopted by A.P Transco.

5. The promotion orders is subject to result of final allocation of State Cadre employees between AP TRANSCO and TS TRANSCO that may occur as per the A.P. Reorganisation Act, 2014, besides subject to the outcome of batch of writ petitions No.16849/2015 and others pending before the Hon'ble High Court and also the batch of SLPs (Civil) No.20901/2015 and others pending before the Hon'ble Supreme Court of India.

6. After final bifurcation if there are any changes in seniority it will be reflected and appropriate change will be made based on Regulation and if the officer who is promoted now is affected by such revision he/she should have to forego the promotion and will be reverted back to the present post.

7. The promotions ordered in para-1 above are without prejudice to the seniority of Officers that will emerge after review of F.C.G List of Senior Accountants and Accountants as on 1-11-1956.

8. **THREE** Asst. Accounts Officers on temporary promotion as Accounts Officers posted to the posts as noted against their names mentioned in the Annexure appended to this order. Some of the existing Accounts Officer posts are re-designated duly diverting are shown in the table in the Annexure appended to this order. Further, the existing 06 Accounts Officers are transferred and posted to the places noted against their names in the Annexure appended to this order.

9. The concerned controlling Officers are requested to relieve the above Asst. Accounts Officers by making local arrangements pending posting of substitutes in order to enable them to assume charge on promotion as AOs at the place of posting ordered.

10. The Asst. Accounts Officers are directed to assume charge on promotion as Accounts Officer at the place of posting ordered, after obtaining proper relief from the present place of working.

11. The promotees are informed that any request for change of posting will not be entertained and they shall assume charge accordingly within 15 days from the date of receipt of the order, failing which they have to forego all the rights both present and in future for such higher posts. If they fails to join duty within the time limit or evades to join duty, such period till they re-join will be treated as un-authorised absence, besides treating such period of un-authorised absence as 'DIES-NON'. They shall also be liable for disciplinary action.

12. The date of joining of the candidate on promotion as Accounts Officer will be reckoned as date of commencement of probation.
