**ORDER :**

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs – Part-II, as adopted by A.P TRANSCO, Sri M. Ravi Kumar, Assistant Divisional Engineer/Elecl., is promoted temporarily to act as Divisional Engineer/Elecl., with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary for administrative convenience and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion ordered in para-1 above is without prejudice to the seniority of the Officers that will emerge after review of F.C.G List of Asst. Engineers of Electricity Department as on 01-11-1956.

4. The promotion ordered is also subject to result of Writ Appeal filed by the retired officers of erstwhile A.P.S.E. Board against the judgement in W.P.No. 2360–91/1983 and pending in the Hon'ble Supreme Court. 5. The promotion orders is subject to result of final allocation of State Cadre employees between AP TRANSCO and TS TRANSCO that may occur as per the A.P. Reorganisation Act, 2014, besides subject to the outcome of batch of writ petitions No.16849/2015 and others pending before the Hon'ble High Court and also the batch of SLPs (Civil) No.20901/2015 and others pending before the Hon'ble Supreme Court of India.

6. After final bifurcation if there are any changes in seniority it will be reflected and appropriate change will be made based on Regulation and if the officer who is promoted now is affected by such revision he/she should have to forego the promotion and will be reverted back to the present post.

7. Sri M. Ravi Kumar, Assistant Divisional Engineer/Elecl, on temporary promotion as Divisional Engineer/Elecl., ordered in para -1 is posted on promotion to the place of noted against his names as mentioned in the Annexure appended to this order and the existing **Four** Divisional Engineers/Elecl., are transferred and posted to the places noted against their names in the Annexure appended to this order.

10. 4 nos. DEs/Elecl who have been transferred to the places noted against their names in the Annexure appended to this order are informed that they are not entitled for TTA and joining time as transfer orders are issued at their own request.

11. The promotee is informed that any request for change of posting will not be entertained and he shall assume charge accordingly after obtaining proper relief from the present place of working within 15 days from the date of receipt of the orders, failing which he has to forego all the rights both at present and in future for such higher post. If he fail to join duty within the time limit or evade to join duty such period till he re-join will be treated as un-authorized absence, besides treating such period of un-authorized absence as 'DIES-NON'. He shall also be liable for disciplinary action.

12. The date of joining of the candidate on promotion as Divisional Engineer/Elecl., will be reckoned as date of commencement of probation.

O R D E R :

In T.O.O. (Addl. Secy.Per) Ms.No.231 dt.23.12.2008 orders were issued to count the services rendered under contract appointments in the cadres of Asst. Engineer, Junior Accounts Officer and LDC-Cum-Computer Operator as regular service for the purpose of seniority only, without any monetary benefits such as increments, notional pay fixation, leave benefits etc.. The above T.O.O was challenged in W.P. No. 29418/2010 filed by Sri B. Gopalu and others in Hon'ble High Court of AP. The Hon'ble Court in its Judgment dt. 18.10.2011 has ordered to treat the contract service in the cadre of AE/Elecl as regular service for the purpose of seniority while giving promotions to the cadre of ADE/Elecl. As per the above orders, the regular/incharge promotions to the cadre of Assistant Divisional Engineer (Elecl) were issued in respect of certain AEs/Elecl and AAEs/Elecl vide T.O.Os 1 to 6 in the reference cited above, based on the seniority list of AEs/Elecl wherein the "AEs appointed by transfer" were placed below the "AEs/Elecl on contract basis".

2. Subsequently, the Hon'ble High Court in its judgement dt. 17.09.2013 in the Writ Appeal No. 1182 of 2011 and its orders dt. 22.04.2015 in WAMP 3665 of 2013 in the above Writ Appeal, set aside the orders issued in T.O.O.No.231, dated 23.12.2008 and held that the Assistant Engineers appointed on contract basis are not entitled to reckon their contract service for the purpose of seniority. Further, a Special Leave Petition was filed by "AEs/Elecl appointed on contract basis" in the Hon'ble Supreme Court. The Hon'ble Court passed Final orders dt.23.01.2017 in SLP Nos.13858-13859/2015, 15389-15390 of 2015 and batch cases duly dismissing the SLPs filed in the said court. As per the above orders the seniority of AEs (Elecl) was revised after considering the objections from the concerned and the final revised seniority was communicated vide memo dt. 07.03.2017 vide ref 8<sup>th</sup> cited. Accordingly it was reviewed for restoration of notional seniority/promotion in respect of certain AEs/ Elecl as ADEs/Elecl.

3. Consequent on review of the panels dt. 30.11.2011, 20.04.2013 and 20.01.2016, the DPC has recommended the names of following AEs/Elecl for notional promotion as ADEs/Elecl w.e.f. the date of assumption of charge of their immediate juniors on promotion as ADEs/Elecl from the above relevant panels as per Reg 8 (2) (a) and (c) of APSEB SRs Part –II as adopted by AP Transco. However they are entitled for monetary benefit only w.e.f. the date of actual assumption of charge on promotion as ADE/Elecl.

Manohar Reddy (Roster Point. 50) in the approved list dt. 30.11.2011 of AE/AAEs/Elecl.
- ii. Sarvasri Ranga Prem Kumar (TS), Shaik. Mastan Valli (AP), R. Rama Krishna, (AP), N Vijayakumar (AP), A.M. Venugopala Swamy (AP), K. Ravindra Babu (AP), K. Chandra Mohan Giri (AP), S. Dada Hayath Khalendar (TS), R.V. Jaya Balakrishna (AP), T. Mahesh Babu (TS), M. Sudhakar Rao (AP), B. Babu (AP), B. T. Ganesh (AP), SK. Abdul Khadar (AP), A. J. Ananda Raju (TS), AEs/Elecl shall be notionally promoted as ADEs/Elecl w.e.f. the date of assumption of charge of their junior Smt. G. Sangeetha, on promotion as ADE/Elecl i.e. 15.12.2011 and they shall be placed below Sri C. Manohar Reddy (Roster Point. 50) and above Smt G. Sangeetha (Roster Point 51) in the approved list dt. 30.11.2011 of AEs/AAEs/Elecl.

- iii. Sarvasri D. Kanakaiah (TS), P. Nagendra (TS), S. Satyanarayana raju (AP), and B. Bhaskar (AP), AEs/Elecl shall be notionally promoted as ADEs/Elecl w.e.f. the date of assumption of charge of their junior Smt. J. Lakshmi Sunitha, on promotion as ADE/Elecl i.e. 11.08.2013, they shall be placed below Smt. S. Rama Devi (Roster Point 128) in the approved list dt. 30.11.2011 of AEs/AAEs/Elecl and above Smt. J. Lakshmi Sunitha (Roster Point 129) in the approved list dt. 20.04.2013 of AEs/AAEs/Elecl.
- iv. Saravasri R. Harinath (AP) and V. Ravindra Reddy (AP), AEs/Elecl shall be notionally promoted as ADEs/Elecl w.e.f. the date of assumption of charge of their junior Sri K. Rajesh Babu on incharge promotion as ADE/Elecl i.e. 03.02.2016. They shall be placed below Sri G. Suresh Babu (Roster Point 139) in the approved list dt. 20.04.2013 of AEs/AAEs/Elecl and above Sri K. Rajesh Babu (I/C), (Roster Point 143) in the approved list dt. 20.01.2016 of AEs/AAEs/Elecl.
