O R D E R :

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs – Part-II as adopted by A.P.TRANSCO, **ELEVEN** Assistant Executive Engineers/Civil mentioned in the Annexure appended to this order are promoted temporarily to act as Executive Engineers /Civil with effect from the date of assumption of charge.

2. The promotions ordered in para-1 above are purely temporary for administrative convenience and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotions ordered in para-1 above are without prejudice to the seniority of the Officers that will emerge after review of F.C.G List of Asst. Engineers of Electricity Department as on 01-11-1956.

4. The promotions ordered are also subject to result of Writ Appeal filed by the retired officers of erstwhile A.P.S.E. Board against the judgment in W.P.No. 2360–91/1983 and pending in the Hon'ble Supreme Court. The promotions are subject to result of Writ Petitions pending in the Hon'ble High Court of A.P., regarding seniority.

5. The promotion orders is subject to result of final allocation of State Cadre employees between AP TRANSCO and TS TRANSCO that may occur as per the A.P. Reorganisation Act, 2014, besides subject to the outcome of batch of writ petitions No.16849/2015 and others pending before the Hon'ble High Court and also the batch of SLPs (Civil) No.20901/2015 and others pending before the Hon'ble Supreme Court of India.

6. After final bifurcation if there are any changes in seniority it will be reflected and appropriate change will be made based on Regulation and if the officer who is promoted now is affected by such revision he/she should have to forego the promotion and will be reverted back to the present post.

7. The **ELEVEN** Assistant Executive Engineers/Civil, on temporary promotion as Executive Engineers/Civil., are posted to the places as indicated against their names in the Annexure appended to this order.

8. The Controlling Officers are requested to relieve the above promotees by making local arrangements pending posting of substitutes to enable them to assume charge on promotion as Executive Engineers/Civil., at the place of posting ordered.

9. The promotees are requested to assume charge on promotion at the place of posting ordered now after obtaining proper relief at the present place of working.

10. The promotees are informed that any request for change of posting will not be entertained and they shall assume charge accordingly after obtaining proper relief from the present place of working within 15 days from the date of receipt of the orders, failing which they have to forego all the rights both at present and in future for such higher post. If they fail to join duty within the time limit or evade to join duty such period till they re-join will be treated as un-authorized absence, besides treating such period of un-authorized absence as 'DIES-NON'. They shall also be liable for disciplinary action.

11. The date of joining of the candidate on promotion as Executive Engineer/Civil., will be reckoned as date of commencement of probation.
