ORDER:

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs – Part-II, as adopted by A.P TRANSCO, <u>36</u> Nos Assistant Engineers/Elecl., and <u>9</u> Nos Addl. Asst. Engineers/Elecl., mentioned in the Annexure appended to this order are ordered temporarily to act as incharge Asst. Divisional Engineers/Elecl., as an adhoc arrangement for administrative convenience without any right to employee on such incharge promotion, with effect from the date of assumption of charge.

- 2. The incharge promotions ordered in para 1 are in the ratio of 1:3:1 as per Note-1 of Reg. 6(b) of A.P.S.E. Board S.Rs Part-III as adopted by A.P. TRANSCO and are subject to passing of limited recruitment test and Accounts Test.
- 3. The incharge promotion orders is subject to result of final allocation of State Cadre employees between AP TRANSCO and TS TRANSCO that may occur as per the A.P. Reorganisation Act, 2014, besides subject to the outcome of batch of writ petitions No.16849/2015 and others pending before the Hon'ble High Court and also the batch of SLPs (Civil) No.20901/2015 and others pending before the Hon'ble Supreme Court of India.
- 4. After final bifurcation if there are any changes in seniority it will be reflected and appropriate change will be made based on Regulation and if the officer who is promoted now is affected by such revision he/she should have to forego the incharge promotion and will be reverted back to the present post.
- 5. The incharge promotions ordered above are purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto. The promotions ordered above are subject to result of appeals filed by the retired officers of erstwhile APSEB against the judgement in W.P.Nos. 2360-91/83 and pending in the Hon'ble Supreme Court and also subject to result of W.P. Nos. 12852/2008, 12129/2008, W.P.No.16185/2009 and Writ Appeal No. 1104/2011 pending in the Hon'ble High Court of Andhra Pradesh regarding seniority. The incharge promotions ordered are also subject to High Court orders dt. 17/9/2013 in WA No.1182/2011 and orders dt. 22.4.2015 in WAMP No.3665/2013 in WA No.1182/2011 and SLP (Civil) No.66-67 of 2016.

- 6. The posting orders to the incharge promotees shall be issued by the respective Zonal Chief Engineers.
- 7. The incharge promotees are requested to assume charge at the place of posting ordered after obtaining proper relief at the present place of working.
- 8. The incharge promotees are informed that any request for change of posting will not be entertained and they shall assume charge accordingly after obtaining proper relief at the present place of working within 15 days from the date of receipt of these orders, failing which they have to forego all the rights both at present and in future for such higher posts. If they fail to join duty within the time limit or evade to join duty such period till they re-join will be treated as un-authorised absence, besides treating such period of un-authorised absence as 'DIES-NON'. They shall also be liable for disciplinary action.
