**O R D E R :**

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs – Part-II, as adopted by A.P TRANSCO, **SEVEN (07)** Nos Assistant Executive Engineers/Civil, and **FOUR (04)** Nos Assistant Engineers/Civil are promoted temporarily to act as Deputy Executive Engineers/Civil with effect from the date of assumption of charge.

2. The promotions ordered in para 1 above are in the ratio of 1:3:1 as per Note-1 of Reg.6(b) of A.P.S.E.Board S.Rs – Part-III as adopted by A.P. TRANSCO and are subject to passing of limited recruitment test and Accounts Test.

3. The promotions ordered above are also subject to result of Writ Appeal filed by the retired officers of erstwhile A.P.S.E. Board against the judgement in W.P.No.2360–91/1983 and pending in the Hon'ble Supreme Court. The promotions are subject to result of Writ Petitions pending in the Hon'ble High Court of A.P., regarding seniority.

5. The promotion orders are subject to result of final allocation of State Cadre employees between AP TRANSCO and TS TRANSCO that may occur as per the A.P. Re-organisation Act, 2014, besides subject to the outcome of batch of writ petitions No.16849/2015 and others pending before the Hon'ble High Court and also the batch of SLPs (Civil) No.20901/2015 and others pending before the Hon'ble Supreme Court of India.

6. After final bifurcation, if there are any changes in seniority it will be reflected and appropriate change will be made based on Regulation and if the officer who is promoted now is affected by such revision he/she should have to forego the promotion and will be reverted back to the present post.

7. The promotees are requested to assume charge at the place of posting ordered after obtaining proper relief at the present place of working.

8. The promotees are informed that any request for change of posting will not be entertained and they shall assume charge accordingly after obtaining proper relief at the present place of working within 15 days from the date of receipt of these orders, failing which they have to forego all the rights both at present and in future for such higher posts. If they fail to join duty within the time limit or evade to join duty such period till they re-join will be treated as un-authorised absence, besides treating such period of un-authorised absence as 'DIES-NON'. They shall also be liable for disciplinary action.
