O R D E R :

In T.O.O. (Addl. Secy.Per) Ms.No.231 dt.23.12.2008 orders were issued to count the services rendered under contract appointments in the cadres of Asst. Engineer, Junior Accounts Officer and LDC-Cum-Computer Operator as regular service for the purpose of seniority only, without any monetary benefits such as increments, notional pay fixation, leave benefits etc.. The above T.O.O was challenged in W.P. No. 29418/2010 filed by Sri B. Gopalu and others in Hon'ble High Court of AP. The Hon'ble Court in its Judgment dt. 18.10.2011 has ordered to treat the contract service in the cadre of AE/Civil as regular service for the purpose of seniority while giving promotions to the cadre of AEE/Civil. As per the above orders, the regular promotions to the cadre of Assistant Executive Engineer (Civil) were issued in respect of certain AEs/Civil vide T.O.Os 1 to 3 in the reference cited above, based on the then seniority list of AEs/Civil wherein the "AEs/Civil appointed by transfer" were placed below the "AEs/Civil appointed on contract basis".

2. Subsequently, the Hon'ble High Court in its judgment dt. 17.09.2013 in the Writ Appeal No. 1104 of 2011 and also its orders dt. 22.04.2015 in WAMP 3665 of 2013 in the Writ Appeal No. 1182 of 2011, set aside the orders issued in T.O.O.No.231, dated 23.12.2008 and held that the Assistant Engineers appointed on contract basis are not

entitled to reckon their contract service for the purpose of seniority. Further, a Special Leave Petition was filed by "AEs appointed on contract basis" in the Hon'ble Supreme Court. The Hon'ble Court passed Final orders dt.23.01.2017 in SLP Nos.13858-13859/2015, 15389-15390 of 2015 and batch cases duly dismissing the SLPs filed in the said court. As per the above orders the seniority of AEs (Civil) was revised after considering the objections from the concerned employees and the final revised seniority of AEs/Civil was communicated in memo dt. 07.03.2017 vide ref 5th cited. Accordingly it was reviewed for restoration of notional seniority/promotion in respect of certain AEs/Civil as AEEs/Civil.

3. Consequent on review of the panels dt. 31.12.2012 and 29.05.2014 the DPC has recommended the names of following AEs/Civil for considering notional promotion as AEEs/Civil w.e.f. the date of assumption of charge of their immediate junior on promotion as AEE/Civil from the above approved lists as per Reg 8 (2) (a) and (c) of APSEB SRs Part –II as adopted by AP Transco. However they are entitled for monetary benefit only w.e.f. the date of actual assumption of charge on promotion as AEE/Civil.

4. After careful consideration, the AP Transco issues following orders:

- i. Sarvasri. K. Srinivas, AEE/Civil (AP) M. Sreenivasulu (TS), CH. Kondala Rao (AP), P. Srinivasa Rao (AP) and Kishore Kumar Raja (AP) AEs/Civil shall be notionally promoted as AEEs/Civil w.e.f the date of assumption of charge of their junior Smt M. Satyavathi (Roster Point 46) on promotion as AEE/Civil i.e. 12.03.2013 and they shall be placed below Sri A. Ravi Kiran (Roster Point 45) and above Smt M. Satyavathi (Roster Point 46) in the approved list dt. 31.12.2012 of AEs/Civil.
- ii. Sarvasri P. Giridhar (AP) and K.V. Krishna (TS) AEs/Civil shall be notionally promoted as AEEs/Civil w.e.f the date of the approved list of AEs/Civil i.e. 29.05.2014 since the said panel was approved and the promotion orders were not issued to those already empanelled and they shall be placed below Sri D. Kishore Kumar Raja (Proposed Roster Point 50) in the approved list dt. 31.12.2012 of AEs/Civil and included in the approved list dt. 29.05.2014 of AEs/Civil.

5. The notional promotions are temporary for administrative convenience.

6. The promotion orders is subject to result of final allocation of State Cadre employees between AP TRANSCO and TS TRANSCO that may occur as per the A.P. Reorganisation Act, 2014, besides subject to the outcome of batch of writ petitions No.16849/2015 and others pending before the Hon'ble High Court and also the batch of SLPs (Civil) No.20901/2015 and others pending before the Hon'ble Supreme Court of India.

7. After final bifurcation, if there are any changes in seniority it will be reflected and appropriate change will be made based on Regulation and if the officer who is promoted now is affected by such revision he/she should have to forego the promotion and will be reverted back to the present post.

8. The notional promotions ordered in para 4 above are purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

9. The notional promotions ordered are also subject to final outcome of Writ Petitions, pending if any, in the Hon'ble High court of the state of Telangana and the state of Andhra Pradesh.
