ORDER :

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs – Part-II, as adopted by APTRANSCO, Sri A. Ramachandra Murthy Naidu, Accounts Officer is promoted temporarily to act as Senior Accounts Officer with effect from the date of actual assumption of charge.

2. The promotion ordered in para-1 above is purely temporary for administrative convenience and liable to be terminated at any time without notice and without assigning any reasons thereto.
