ORDER :

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs – Part-II, as adopted by A.P Transco, the following **THREE** Accounts Officers are promoted temporarily to act as Senior Accounts Officers with effect from the date of assumption of charge.

- ii) Sri K. V. Satyanarana Murthy, AO
- iii) Sri M.L.N. Sarma, AO

2. The promotions ordered in para-1 above are purely temporary for administrative convenience and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotions ordered in para-1 above are also as per Rule of reservation in promotion in favour of S.Cs & S.Ts as adopted by A.P Transco.

4. The promotions ordered in para-1 above are subject to result of appeals filed by the retired officers of erstwhile A.P.S.E. Board against the judgement in W.P No. 2360-91/83 pending in the Hon'ble Supreme Court of India and W.P No.1173/91 pending in the Hon'ble High Court of A.P.

5. The promotion orders is subject to result of final allocation of State Cadre employees between AP TRANSCO and TS TRANSCO that may occur as per the A.P. Reorganisation Act, 2014, besides subject to the outcome of batch of writ petitions No.16849/2015 and others pending before the Hon'ble High Court and also the batch of SLPs (Civil) No.20901/2015 and others pending before the Hon'ble Supreme Court of India.

6. After final bifurcation if there are any changes in seniority it will be reflected and appropriate change will be made based on Regulation and if the officer who is promoted now is affected by such revision he/she should have to forego the promotion and will be reverted back to the present post.

7. Sri V.D. Sarveswara Rao, Accounts Officer/400 KV/Vijayawada on temporary promotion as Senior Accounts Officer as ordered above is transferred and posted as Pay Officer/VS/Hyd and Sri K.S. Bhaskar Rao, SAO transferred. Sri K.S. Bhaskar Rao, SAO on transfer is posted as SAO/TLC/Visakhapatnam.

8. Sri K. V. Satyanarana Murthy, AO/ OMC/Eluru on temporary promotion as Senior Accounts Officer as ordered above is transferred and posted as SAO/APCC/VS/Hyd.

9. Sri M.L.N. Sarma, AO/GPF/VS/Hyd on temporary promotion as Senior Accounts Officer as ordered above is transferred and posted as SAO/VS/HYd in the existing vacancy.
10. The concerned Controlling Officers are requested to relieve the above Accounts Officers by making local arrangements pending posting of substitutes in order to enable them to assume charge on promotion as SAO at the place of posting ordered.
11. The promotees are requested to assume charge on promotion as Senior Accounts Officer at the place of posting ordered above after obtaining proper relief from the present place of working.
12. The promotees are informed that any request for change of posting will not be entertained and they shall assume charge accordingly within 15 days from the date of receipt of the order, failing which they have to forego all the rights both at present and in future for such higher posts. If they fail to join duty within the time limit or evade to join duty such period till they re-join will be treated as un-authorized absence, besides treating such period of un-authorized absence as 'DIES-NON'. They shall also be liable for disciplinary action.
13. The date of joining of the candidate on promotion as Senior Accounts Officer will be reckoned as date of commencement of probation.
