**ORDER :**

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs – Part-II, as adopted by A.P Transco, Smt. R. Neeraja, Assistant Secretary/(Estt & Pensions)/VS/ Vijayawada is promoted temporarily to act as Deputy Secretary with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion ordered in para-1 above is subject to result of appeals filed by the Retired Officers of the Board against the Judgement in Writ Petition Nos. 2360-91/83 and pending in the Supreme Court.

4. The promotion ordered in para-1 above are subject to the result of appeal filed by the retired officers of erstwhile APSEB against the judgement in W.P.No.2360-91/83 and pending in the Hon'ble Supreme Court and are also subject to result of Writ Petitions pending in the Hon'ble High Court of A.P regarding seniority.

5. The promotion order is subject to result of final allocation of State Cadre employees between AP TRANSCO and TS TRANSCO that may occur as per the A.P. Re-Organisation Act, 2014, besides subject to the outcome of batch of writ petitions No.16849/2015 and others pending before the Hon'ble High Court and also the batch of SLPs (Civil) No.20901/2015 and others pending before the Hon'ble Supreme Court of India.

6. After final bifurcation if there are any changes in seniority it will be reflected and appropriate change will be made based on Regulation and if the officer who is promoted now is affected by such revision he/she should have to forego the promotion and will be reverted back to the present post.

7. The posting orders to the above Assistant Secretary on promotion as Deputy Secretary will be issued separately by the competent authority.

8. The promotee is requested to assume charge at the place of posting on receipt of posting orders to be issued by the competent authority and no request for change of posting will be entertained and she shall assume charge accordingly, after obtaining proper relief within 15 days from the date of receipt of the order, failing which she has to forego all the rights both present and future for such higher post. If she fails to join duty within the time limit or evades to join duty, such period till she re-joins will be treated as unauthorised absence. Besides treating the above period as 'DIES-NON', she shall also be liable for disciplinary action.

9. The date of joining of the candidate on receipt of posting orders on promotion as Deputy Secretary will be reckoned as date of commencement of probation.
