ORDER :

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs – Part-II as adopted by A.P Transco, Sri.K.Srinivas, Executive Engineer/ Civil is promoted temporarily to act as Superintending Engineer/ Civil with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary for administrative convenience and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion ordered in para-1 above is subject to result of appeals filed by the retired officers of erstwhile APSEB against the judgment in W.P.Nos.2360-91/83 and pending in the Hon'ble Supreme Court.

4. The promotion orders are subject to result of final allocation of State Cadre employees between AP TRANSCO and TS TRANSCO that may occur as per the A.P. Reorganization Act, 2014. After final bifurcation if there are any changes in seniority it will be reflected and appropriate changes will be made based on Regulation and if the officer who is promoted now, is affected by such revision he/she should have to forego the promotion and will be reverted back to the present post.

5. Sri.K.Srinivas, Executive Engineer/Civil on temporary promotion as Superintending Engineer/Civil is posted as Superintending Engineer/ Civil/ APTRANSCO/Vijayawada.

6. Sri.M.Venkata Subbaiah, Executive Engineer/Civil, O/o. the Chief Engineer/ Consturction/Vidyut Soudha/Vijayawada is transferred and posted as Executive Engineer/Civil O/o.CE/PRTI/Visakhapatnam.

7. The concerned Controlling Officers are requested to relieve the above Executive Engineers/Civil immediately to enable them to assume charge at the place of posting ordered above.

8. The above officers are requested to assume charge at the place of posting ordered after obtaining proper relief from the present place of working.

9. The promotee is informed that no request for change of posting will be entertained and he shall assume charge accordingly after obtaining proper relief within 15 days from the date of relief, failing which he has to forego all the rights both at present and in future for such higher post. If he fails to join duty within the time limit or evade to join duty such period till he re-joins will be treated as un-authorized absence, besides treating such period of un-authorized absence as 'DIES-NON'. He shall also be liable for disciplinary action.
