O R D E R :

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs–Part-II, as adopted by APTRANSCO, the following **TWO** Executive Engineers/Elecl, are promoted temporarily to act as Superintending Engineers/Elecl., with effect from the date of assumption of charge.

2. Sri K.S.Basha

2. The promotions ordered in para-1 above are purely temporary for administrative convenience and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotions ordered are also without prejudice to the seniority of the Officers that will emerge after review of F.C.G List of Asst. Engineers of Electricity Department as on 1-11-1956 is finalized.

4. The promotion orders are subject to result of final allocation of State Cadre employees between AP TRANSCO and TS TRANSCO that may occur as per the A.P. Reorganization Act, 2014. After final bifurcation if there are any changes in seniority it will be reflected and appropriate changes will be made based on Regulation and if the officers who are promoted now are affected by such revision he/she should have to forego the promotion and will be reverted back to the present post.

5. The above promotions are subject to the result of Appeal filed by the retired officers of erstwhile APSE Board against the judgment in W.P.No.2360-91/83 and pending in the Hon'ble Supreme Court and are also subject to result of Writ Petitions pending in Honorable High Court of A.P.

6. Smt.V.Anuradha, EE/Elecl., on temporary promotion as Superintending Engineer/Electrical is transferred and posted as Superintending Engineer/Procurement under the control of Chief Engineer/Transmission/ APTRANSCO/Vidyut Soudha/Vijayawada

7. On temporary promotion as Superintending Engineer/Electrical, the posting orders to Sri.K.S.Basha, EE/Elecl., will be issued separately.

The promotees are informed that they have to assume charge after obtaining proper relief from the present place of working within 15 days from the date of receipt of the posting orders, failing which they have to forego all the rights both at present and in future for such higher post. If they fail to join duty within the time limit or evade to join duty, such period till they re-joins will be treated as un-authorized absence, besides treating such period of un-authorized absence as 'DIES-NON'. They shall also be liable for disciplinary action.
