O R D E R :

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs – Part-II, as adopted by A.P Transco, **SEVEN** Junior Accounts Officers mentioned in the Annexure appended to this order are promoted temporarily to act as Assistant Accounts Officers with effect from the date of assumption of charge.

2. The promotions ordered in para-1 above are purely temporary for administrative convenience and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotions ordered in para-1 above are also as per Rule of Reservation in promotion in favour of S.Cs & S.Ts as adopted by A.P Transco.

4. The promotions ordered in para-1 above are subject to result of appeals filed by the Retired officers of the erstwhile APSE Board against the judgement in W.P Nos.2360-91/83 and pending in the Hon'ble Supreme Court of India and also subject to the result of WP.No. 24684/09 pending in the Honb'le High Court of A.P.

5. The promotion orders is subject to result of final allocation of State Cadre employees between AP TRANSCO and TS TRANSCO that may occur as per the A.P. Reorganisation Act, 2014, besides subject to the outcome of batch of writ petitions No.16849/2015 and others pending before the Hon'ble High Court and also the batch of SLPs (Civil) No.20901/2015 and others pending before the Hon'ble Supreme Court of India.

6. After final bifurcation if there are any changes in seniority it will be reflected and appropriate change will be made based on Regulation and if the officer who is promoted now is affected by such revision he/she should have to forego the promotion and will be reverted back to the present post.

7. **SEVEN** Junior Accounts Officers on temporary promotion as Assistant Accounts Officers and **THREE** existing AAOs are transferred and posted to the places noted against their names mentioned in the Annexure appended to this order.

8. The concerned controlling officers are requested to relieve the above Junior Accounts Officers by making local arrangements pending posting of substitutes to enable them to assume charge on promotion as AAO at the place of posting ordered above.

9. The Assistant Accounts Officers transferred are also directed to assume charge at the place of posting now ordered after obtaining proper relief from the present place of working.

10. The promotees are informed that any request for change of posting will not be entertained and they shall assume charge accordingly after obtaining proper relief within 15 days from the date of receipt of order, failing which they have to forego all the rights both at present and in future for such higher posts. If they fail to join duty within the time limit or evade to join duty by proceeding on leave, such period will be treated as un-authorised absence, besides treating such period of un-authorised absence as 'DIES-NON'. They shall also be liable for disciplinary action.

11. The date of joining of the candidate on promotion as Asst. Accounts Officer will be reckoned as date of commencement of probation.
