O R D E R :

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs – Part-II as adopted by A.P Transco, **FOUR** Personnel Officers mentioned in the Annexure appended to this order are promoted temporarily to act as Assistant Secretaries with effect from the date of assumption of charge.

2. The promotions ordered in para-1 above are purely temporary for administrative convenience and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotions ordered in para-1 above are subject to result of appeals filed by the retired officers of erstwhile APSEB against the judgment in W.P.Nos.2360-91/83 and pending in the Hon'ble Supreme Court.

4. The promotion orders are subject to result of final allocation of State Cadre employees between AP TRANSCO and TS TRANSCO that may occur as per the A.P. Reorganization Act, 2014. After final bifurcation if there are any changes in seniority it will be reflected and appropriate changes will be made based on Regulation and if the officers who are promoted now are affected by such revision he/she should have to forego the promotion and will be reverted back to the present post.

5. The **FOUR** Personnel Officers on temporary promotion as Assistant Secretaries are posted to the places as indicated against their names in the Annexure appended to this order.

6. Smt.B.Gayatri Devi, Personnel Officer who has been allotted from TSTRANSCO on final bifurcation and joined in APTRANSCO is directed to submit an undertaking that incase of any disciplinary cases pending or contemplated against her are noticed on receipt of the information from TSTRANSCO at a later date, her promotion will be reviewed accordingly.

7. The Deputy Secretary (Per)/AP Transco/Vidyut Soudha/Vijayawada is directed to obtain the undertaking mentioned at para (6) and submit the same to the Chief General Manager (HR)/APTRANSCO/VS/Vijayawada along with joining CTC of the above Assistant Secretary promotee.

8. The concerned Controlling Officers are requested to relieve the above Personnel Officers immediately by making local arrangements pending posting of substitute to enable them to assume charge on promotion as Assistant Secretaries at the place of posting ordered.

9. The Promotees are requested to assume charge on promotion as Assistant Secretaries at the place of posting ordered after obtaining proper relief from the present place of working.

10. The promotees are informed that no request for change of posting will be entertained and they shall assume charge accordingly after obtaining proper relief within 15 days from the date of issue of the orders, failing which they have to forego all the rights both at present and in future for such higher posts. If they fail to join duty within the time limit or evade joining duty, such period till they re-joins will be treated as un-authorised absence, besides treating such period of un-authorised absence as 'DIES-NON'. They shall also be liable for disciplinary action.

11. The date of joining of the candidates on promotion as Assistant Secretaries will be reckoned as date of commencement of probation.
