**ORDER :**

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs–Part-II as adopted by A.P Transco, Sri P.V. Subba Raju, Senior Accounts Officer is promoted temporarily to act as Deputy Chief Controller of Accounts with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary for administrative convenience and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion orders are subject to result of final allocation of State Cadre employees between AP TRANSCO and TS TRANSCO that may occur as per the A.P. Re-Organisation Act, 2014, besides subject to the outcome of batch of writ petitions No.16849/2015 and others pending before the Hon'ble High Court and also the batch of SLPs (Civil) No.20901/2015 and others pending before the Hon'ble Supreme Court of India.

4. After final bifurcation if there are any changes in seniority it will be reflected and appropriate change will be made based on Regulation and if the officer who is promoted now is affected by such revision he/she should have to forego the promotion and will be reverted back to the present post.

5. The promotion ordered in para-1 above is subject to result of appeals filed by the retired officers of erstwhile APSEB against the judgement in W.P.Nos.2360-91/83 and pending in the Hon'ble Supreme Court.

6. Sri P.V.Subba Raju, SAO on temporarily promoted as Dy.CCA ordered in para-1 above and posted as Dy.CCA/R&E/Vidyut Soudha/Vijayawada

7. Sri.Ch.Suryanarayana Murthy, DY.CCA is transferred and posted as DY.CCA (A/Cs)/APTransco/Vidyut Soudha/Vijayawada under the control of FA &CCA (A/Cs).

8. The above officers are requested to assume charge accordingly at the place of posting ordered above after obtaining proper relief from the present place of working.

9. The promotee is informed that any request for change of posting will not be entertained and he shall assume charge accordingly after obtaining proper relief within 15 days from the date of relief, failing which he has to forego all the rights both at present and in future for such higher posts. If he fails to join duty within the time limit or evades to join duty such period till he re-joins will be treated as un-authorized absence, besides treating such period of un-authorized absence as 'DIES-NON', he shall also be liable for disciplinary action.

10. The date of joining of the candidate on promotion as Dy. CCA will be reckoned as date of commencement of probation.
