ORDER :

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs–Part-II, as adopted by APTRANSCO, Sri S. Ananda Rao, Superintending Engineer/Telecom., is promoted temporarily to act as Chief Engineer/Telecom., with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary for administrative convenience and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion ordered is also without prejudice to the seniority of the Officers that will emerge after review of F.C.G List of Asst. Engineers of Electricity Department as on 1-11-1956 is finalized.

4. The promotion order is subject to result of final allocation of State Cadre employees between AP TRANSCO and TS TRANSCO that may occur as per the A.P. Reorganisation Act, 2014, besides subject to the outcome of batch of writ petitions No.16849/2015 and others pending before the Hon'ble High Court and also the batch of SLPs (Civil) No.20901/2015 and others pending before the Hon'ble Supreme Court of India.

5. After final bifurcation if there are any changes in seniority it will be reflected and appropriate change will be made based on Regulation and if the officer who is promoted now is affected by such revision he/she should have to forego the promotion and will be reverted back to the present post.

6. The above promotion is subject to the result of Appeal filed by the retired officers of erstwhile APSE Board against the judgement in W.P.No.2360-91/83 and pending in the Hon'ble Supreme Court and is also subject to result of W.P.No. 4219 of 1978 and W.P. No. 24489/2006 pending in Hon'ble High Court of A.P.

7. Sri S. Ananda Rao, Superintending Engineer/Telecom on temporary promotion as Chief Engineer/Telecom., is posted on promotion as Chief Engineer/Telecom & IT/VS/Hyderabad.

8. The Controlling Officer is requested to relieve the above Superintending Engineer/Telecom by making local arrangements pending posting of substitute to enable him to assume charge on promotion as Chief Engineer/Telecom at the place of posting ordered.

9. The promotee is requested to assume charge as Chief Engineer/Telecom & IT/Vidyut Soudha/Hyderabad, after obtaining proper relief at the present place of working.

10. The promotee is informed that any request for change of posting will not be entertained and he shall assume charge accordingly after obtaining proper relief from the present place of working within 15 days from the date of receipt of these orders, failing which he has to forego all the rights both at present and in future for such higher post. If he fails to join duty within the time limit or evades to join duty such period till he re-joins will be treated as un-authorized absence, besides treating such period of un-authorized absence as 'DIES-NON'. He shall also be liable for disciplinary action.

11. The date of joining of the candidate on promotion as Chief Engineer/Telecom., will be reckoned as date of commencement of probation.
