Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs - Part-II as adopted by A.P TRANSCO, **THREE** Senior Assistants mentioned in the Annexure appended to this order are promoted temporarily to act as Junior Accounts Officers with effect from the date of taking charge.

2. The promotion ordered above are as per Rule of reservation in promotion in favour of S.Cs & S.Ts as adopted by A.P TRANSCO.

3. The promotion orders is subject to result of final allocation of State Cadre employees between AP TRANSCO and TS TRANSCO that may occur as per the A.P. Reorganisation Act, 2014, besides subject to the outcome of batch of writ petitions No.16849/2015 and others pending before the Hon'ble High Court and also the batch of SLPs (Civil) No.20901/2015 and others pending before the Hon'ble Supreme Court of India.

4. After final bifurcation if there are any changes in seniority it will be reflected and appropriate change will be made based on Regulation and if the officer who is promoted now is affected by such revision he/she should have to forego the promotion and will be reverted back to the present post.

5. They are informed that promotions ordered in para-1 above are purely temporary and do not confer on them any preferential right for future promotion or any other service benefits at a later date and are liable to be terminated without notice and without assigning any reasons thereto.

6. The **THREE** Senior Assistants on their promotion as Junior Accounts Officers are transferred and posted to the places noted against their names mentioned in the Annexure appended to this order.

7. The promotees are directed to report for duty at the place of posting ordered, after obtaining proper relief from the present place of working.

8. The Controlling Officers are requested to relieve the above Senior Assistants by making local arrangements pending posting of substitutes in order to enable them to assume charge on promotion as JAO at the place of posting ordered above.

P.T.O

9. The promotees are informed that any request for change of posting will not be entertained and they shall assume charge accordingly after obtaining proper relief from the present place of working within 15 days from the date of receipt of the orders, failing which they have to forego all the rights both at present and in future for such higher post. If they fail to join duty within the time limit or evade to join duty such period till they re-join will be treated as un-authorised absence, besides treating such period of un-authorised absence as 'DIES-NON'. They shall also be liable for disciplinary action.

10. The date of joining of the candidate on promotion as Junior Accounts Officer will be reckoned as date of commencement of probation.
