O R D E R:

4) Penal Interest shall be charged at double the rate of normal interest in case the advances are mis-utilized or not utilized at all and 1.5 times the normal rate for non-compliance with formalities.

5) All other conditions governing the sanction of above advance under the existing rules shall continue.

6) Past cases in which orders were already issued granting the above advances shall not be reopened.

7) These orders shall come into force from the date of issue of the orders.
