ORDER:-

In the reference 1st cited, orders were issued for sanction of an amount of Rs.1,75,442/- (Rupees One Lakh Seventy Five Thousand and Four Hundred Forty Two only) towards medical coverage premium including GST @ 18%, for payment of annual premium to M/s National Insurance Company Limited, Divisional Office -2, Vijayawada, for renewal of the Group Personal Accident Insurance Cover of Rs.15,00,000/- (Rupees Fifteen Lakhs only) each or 72 times of the gross pay of the each individual, whichever is less, for the existing 59 Nos. (Fifty Nine only) of Hot Line Trained Staff working in Hotlines Wing of AP Transco for the period from 10.09.2020 to 09.09.2021.

2. In the reference 2nd cited, the Chief Engineer/PS, Plg & Designs has stated that the existing Group Personal Accident (GPA) Insurance cover with M/s National Insurance Company Limited, Vijayawada referred to at para (1) above is being expired on 09.09.2020 and proposed to renew the coverage of above said Insurance Policy of Rs.15,00,000/- to each of the Hot Lines Trained Staff (59 Nos.) working in Hotlines Wing of AP Transco for a further period of one year from 10.09.2020 to 09.09.2021 by sanctioning an amount of Rs.1,75,442/- towards Medical Coverage annual premium and GST @18% for payment to M/s National Insurance Company Limited, Divisional Office-2, Vijayawada.

3. After careful examination of the proposal of Chief Engineer/ PS, Plg & Designs /Vidyut Soudha, Vijayawada, the AP Transco hereby accords approval for sanction of an amount of Rs. 1,69,070/- (Rupees One Lakh Sixty Nine Thousand and Seventy only) towards Medical Coverage annual premium including GST 18%, for payment to M/s National Insurance Company Limited, Divisional Office-2, Vijayawada for renewal of the Group Personal Accident (GPA) Insurance coverage of Rs.15,00,000/- (Rupees Fifteen Lakhs only) each or 72 times of the gross pay of the each individual whichever is less, for existing 59 Nos. (Fifty Nine) of Hotline Trained Staff, working in Hotlines wing of AP Transco for the period from 10.09.2020 to 09.09.2021.

4. The amount sanctioned in para (3) above is subject to the Budget Provision to be made by the Chief Engineer/Transmission, Vidyut Soudha, Vijayawada.
