ORDER:

Consequent to the orders issued vide references cited above, APTransco after careful examination, APTRANSCO hereby enhances the ceiling limits of the existing Medical policy as follows:

General Ailments:

The existing amount of Rs.3.00 Lakhs for life time for general ceiling is enhanced to Rs.5.00 Lakhs.

Self Funding Scheme:

Existing ceiling of Rs.3.00 Lakhs under Self-Funding Scheme is enhanced to Rs.6.00 Lakhs per family per year over and above the General ceiling and Major ceiling as per the CGHS / NIMS tariff rates and enhanced the monthly contribution from Rs.100/- per month to Rs.500/- per month from Employees / Pensioners/ Family Pensioners. It will be reviewed every 6 months.

Major Ailments

The existing amount of Rs.8.00 Lakhs for Major ailments/Surgeries/Treatments i.e., CABG, Double Valve Replacement, Kidney Transplantation, Cancer, Neurosurgery, Aortic Valve Replacement, PTCA STENT be restricted to three spells for each of these diseases maximum ceiling limit of Rs.2.00 Lakhs for 1st & 2nd spell and Rs.4.00 Lakhs for 3rd spell. The existing amount is enhanced to Rs.12.00 Lakhs in three spells i.e, Rs.4.00 Lakhs for each spell.

2. The enhanced General/Major/SFMS Ceiling limits come into force with effect from the date of issue of this order. Further, the Employees/Pensioners/Family Pensioners and their dependents who have already availed medical facility prior to this order, the same will be adjusted from the enhanced ceilings.

3. The enhanced contribution of Rs.500/- per month towards Self Funding Medical Scheme will be deducted from the Salary/Pension/Family Pension of October-2018 payable in the month of November-2018 from Employees/ Pensioners/ Family Pensioners.

4. This order shall come into force for the treatment taken on or after the date of issue of the order.

5. The other orders relating to existing medical scheme issued from time to time holds good.

6. The next revision of Medical Policy will be implemented after four (4) years i.e. from the date of these orders issued.

7. These orders are issued with the concurrence of J.M.D (Fin., Comml, IPC, HRD & IT) vide Regd.No.310, dated:28-09-2018.
