Under Regulation 14(a)(1) of A.P.S.E. Board Service Regulations – Part-II as adopted by A.P.TRANSCO, Sri.S.K. Khaja Mynuddin, Typist is promoted temporarily to act as Sr. Assistant with effect from the date of assumption of charge.

2. The promotions ordered in para-1 above are purely temporary for administrative convenience and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion order is subject to result of final allocation of State Cadre employees between AP TRANSCO and TS TRANSCO that may occur as per the A.P. Re-organization Act, 2014, besides subject to the outcome of batch of writ petitions No.16849/2015 and others pending before the Hon'ble High Court and also the batch of SLPs (Civil) No.20901/2015 and others pending before the Hon'ble Supreme Court of India.

4. After final bifurcation if there are any changes in seniority it will be reflected and appropriate change will be made based on Regulation and if the officer who is promoted now is affected by such revision he/she should have to forego the promotion and will be reverted back to the present post.

5. The promotion ordered in para-1 above is subject to review as per the final outcome of the Hon'ble High Court of A.P that may be passed in the Writ Petitions pending on the issue.

6. Sri S.K. Khaja Mynuddin, Typist on temporary promoted as Sr. Assistant is posted to work under the control of Additional Secretary duly counting against one of the vacant Senior Assistant posts of SAO/F&P, EPF, GPF & Trusts Section.

7. The Concerned Controlling Officer is requested to relieve the above Typist by making local arrangement pending posting of substitute to enable him to join duty on promotion as Sr. Assistant at the place of posting ordered.

8. The promotee is informed that request for change of posting will not be entertained and he shall assume charge accordingly within 15 days from the date or receipt of the order, failing which he has to forego all the rights both present and future for such higher post. If he fail to join duty within the time limit or evade to join duty such period till he re-join will be treated as un-authorized absence, besides treating such period of un-authorized absence as 'DIES-NON'. he shall also be liable for disciplinary action.

9. The date of joining of the candidate on promotion as Sr. Assistant will be reckoned as date of commencement of probation.
