In the memo 1<sup>st</sup> cited, orders were issued that the employees working at APTRANSCO Head Quarters are temporarily allocated and posted to APTRANSCO and TGTRANSCO now TSTRANSCO, as per the new organization structures, to carry out the day-to-day works from the appointed day. The arrangements ordered therein shall be in force till the process of allocation to the respective Corporations are finalized and completed in full shape as per the A.P. Reorganization Act, 2014. In the said orders, Sri/Smt \_\_\_\_\_ was ordered to provisionally serve at APTRANSCO Head Quarters.

2. AP Power Utilities have made all efforts to resolve the request of Telangana Native Employees to relieve them. But due to the effect of pending litigation, and pending finalization of modalities under Section 82 of the A.P. Reorganization Act, 2014 the said request of Telangana native employees who have been working with A.P. Power Utilities under order to serve is found to be not feasible. In fact the Management of A.P. Power Utilities have no powers to interfere with service conditions of employees working with it pending final bifurcation of employees.

3. The present provisional allocation is only for service delivery and in consonance with 'Order to Service' principle. Therefore, the relieving on your own accord without reference to the Management may not be understood as deemed acceptance by APTRANSCO/APGENCO as the same is unknown to Service Law.

4. In the representation cited, Sri/Smt \_\_\_\_\_ has informed "**that you are getting relieved from APTRANSCO with immediate effect i.e. 01.09.2016 FN**" on your own for the reasons stated therein which amounts not only to relinquishment of right as a member of service of APTRANSCO, but also absent from duties without permission in terms of Service Regulations of APTRANSCO..
